## ADDITIONAL REQUIREMENTS

## IF PASSPORT RENEWAL IS FOR A MINOR (BELOW 18) WITH MARRIED PARENTS (AS STATED IN THE MINOR'S PSA BIRTH CERTIFICATE)

COPY OF VALID PASSPORT DATA PAGE OR VALID PHILIPPINE ID OF BOTH PARENTS AS STATED IN THE PSA BIRTH CERTIFICATE.

**NOTE**: THE MOTHER SHOULD PRESENT A VALID ID **CONSISTENT WITH HER MARRIED SURNAME OR MAIDEN SURNAME**. OTHERWISE, THE MINOR'S MOTHER SHOULD PRESENT HER ORIGINAL PSA BIRTH CERTIFICATE AND ITS PHOTOCOPY.



**RED LETTER PACK** 



IF THE MINOR IS NOT ACCOMPANIED BY PARENTS, THE AUTHORIZED ADULT COMPANION MUST PRESENT THE FOLLOWING:

- SPECIAL POWER OF ATTORNEY (SPA) EXECUTED BY EITHER OF THE MINOR'S PARENTS
- IF THE SPA IS EXECUTED ABROAD, IT MUST BE AUTHENTICATED BY THE PH EMBASSY OR CONSULATE OR APOSTILLED BY THE DESIGNATED COMPETENT AUTHORITY
- ORIGINAL AND COPY OF THE PASSPORT OR OTHER COMPETENT PROOF OF IDENTITY OF THE AUTHORIZED COMPANION
- COPY OF THE PASSPORT OR OTHER COMPETENT PROOF OF IDENTITY OF BOTH THE MINOR'S PARENTS.
