INVITATION TO BID FOR THE PROCUREMENT OF ONE (1) BRAND NEW MOTOR VEHICLE

The Philippine Consulate General in Osaka, Japan, through the General Appropriations Act of FY2021 intends to apply the sum of Seven Million Seven Hundred Thousand Japanese Yen (JPY 7,700,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the procurement of one (1) brand new motor vehicle as official car. Bids received in excess of the ABC shall be automatically rejected.

The Philippine Consulate General in Osaka, Japan now invites bids for the procurement of one (1) brand new motor vehicle as official car, with the following basic specifications:

Make/body type	:	4-door sedan
Engine displacement	:	2500cc for gasoline or 3500cc for diesel
Transmission	:	Automatic
Length of chassis	:	Minimum of 5,125mm
Other features	:	GPS navigation system in English, support for electronic toll collection system, alloy wheels with run flat properties, car digital video recorder, rear view camera, parking guidance system, electronic seat adjustment, floor mats, door edge protection, door visors, with 2 spare keys and LED headlights
Exterior color	:	Black
Upholstery	:	Black leather
Warranty	:	Minimum of 3 years warranty

Delivery of said vehicle is required no later than **01 March 2022**.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion pursuant to the guidelines of the Philippine Government Procurement Reform Law (R.A. No. 9184) and Annex "A" of the Government Procurement Policy Board (GPPB) Resolution No. 28-2017.

Bidding is open to all interested local bidders.

Interested bidders may obtain further information from the Philippine Consulate General in Osaka, Japan and request for a copy of the Bidding Documents via email through osaka.pcg@dfa.gov.ph until **14 November 2021, Thursday**.

Bids must be received by the Bids and Awards Committee of the Philippine Consulate at the 24th floor of Twin 21 MID Tower, 2-1-61 Shiromi, Chuo-ku, Osaka City on or before **11:00 a.m. of 15 November 2021, Friday**. Bid opening shall be held at the address above-specified **on the same date at 3:00 P.M.** in the presence of the Bidders' representatives who choose to attend. **Late bids shall not be accepted.**

The Philippine Consulate General in Osaka, Japan reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
